

IPA | Agency COVID-19 Production Risk Overview

There is no production insurance for any COVID-19-related disruption. This document provides a framework to assess a script/concept prior to production, identify where uninsurable COVID-19 production risks may exist, and provide suggestions for how those risks can be mitigated. Client and agency should discuss risks and potential mitigation strategies prior to script approval or any production kick-off.
